1 (Updated Section) Introduction

The WS-Transfer: Identity Management Operations for Directory Access Extensions (henceforth referred to as "IMDA") are a set of extensions to the WS-Transfer protocol [WXFR] for representing the protocol operations commonly used for directory access in identity management protocols.

The goal of this specification is to enable identity management client applications, which are currently using non-Web service protocols such as Lightweight Directory Access Protocol (LDAP) v3 [RFC2251] for managing information held in directory services, to instead use Web service protocols.

This protocol extension is designed to layer atop the WS-Transfer protocol and to be composable with the WS-Management protocol [DMTF-DSP0226].

Sections 1.5, 1.8, 1.9, 2, and 3 of this specification are normative. All other sections and examples in this specification are informative.

1.1 (Updated Section) Glossary

This document uses the following terms:

Active Directory: The Windows implementation of a general-purpose directory service, which uses LDAP as its primary access protocol. Active Directory stores information about a variety of objects in the network such as user accounts, computer accounts, groups, and all related credential information used by Kerberos [MS-KILE]. Active Directory is either deployed as Active Directory Domain Services (AD DS) or Active Directory Lightweight Directory Services (AD LDS), which are both described in [MS-ADOD]: Active Directory Protocols Overview.

Active Directory Domain Services (AD DS): A directory service (DS) implemented by a domain controller (DC). The DS provides a data store for objects that is distributed across multiple DCs. The DCs interoperate as peers to ensure that a local change to an object replicates correctly across DCs. AD DS is a deployment of Active Directory [MS-ADTS].

Active Directory Lightweight Directory Services (AD LDS): A directory service (DS) implemented by a domain controller (DC). AD LDS is a deployment of Active Directory [MS-ADTS]. The most significant difference between AD LDS and Active Directory Domain Services (AD DS) is that AD LDS does not host domain naming contexts (domain NCs). A server can host multiple AD LDS DCs. Each DC is an independent AD LDS instance, with its own independent state. AD LDS can be run as an operating system DS or as a directory service provided by a standalone application (Active Directory Application Mode (ADAM)).

constructed attribute: An attribute whose values are computed from normal attributes (for read) and/or have effects on the values of normal attributes (for write).

dialect: A specification of a format and rules for the expressions comprising an identity attribute type. An identity attribute type can only be understood if it is known what dialect it is written in and how that dialect maps expressions to identity attributes. A dialect is uniquely identified by a URI.

directory attribute: An identifier for a single-valued or multi-valued data element that is associated with a directory object.

directory object: A Lightweight Directory Access Protocol (LDAP) object, as specified in [RFC2251], that is a specialization of an object.

directory service (DS): A service that stores and organizes information about a computer network's users and network shares, and that allows network administrators to manage users' access to the shares. See also Active Directory.

endpoint: In the context of a web service, a network target to which a SOAP message can be addressed. See [WSADDR].

identity attribute: A property of an identity object consisting of one or more identity attribute values. All the values of an identity attribute are related by a common purpose or meaning. For example, the collection of telephone numbers belonging to a user might form an identity attribute on the identity object that represents that user's account. An identity object is an abstraction over physical realizations such as directory attributes. An identity attribute is named by an identity attribute type.

identity attribute type: An expression, written in a dialect, that identifies an identity attribute. The relationship between identity attribute types and identity attributes is many-to-one. An identity attribute type uniquely names an identity attribute, but one identity attribute can be named by multiple identity attribute types, each written in a different dialect. This is analogous to how a directory attribute can be referred to by either an LDAP display name or by an object identifier (OID).

identity attribute value: The value of an identity attribute. For example, in an identity attribute representing a user's telephone numbers, each telephone number is an identity attribute value. Identity attribute values have implementation-defined XML representations.

identity object: An entity that is a collection of one or more identity attributes. For example, an identity object could represent a user's account. An identity object is an abstraction over physical realizations such as directory objects.

Lightweight Directory Access Protocol (LDAP): The primary access protocol for Active Directory. Lightweight Directory Access Protocol (LDAP) is an industry-standard protocol, established by the Internet Engineering Task Force (IETF), which allows users to query and update information in a directory service (DS), as described in [MS-ADTS]. The Lightweight Directory Access Protocol can be either version 2 [RFC1777] or version 3 [RFC3377].

object identifier (OID): In the Lightweight Directory Access Protocol (LDAP), a sequence of numbers in a format described by [RFC1778]. In many LDAP directory implementations, an OID is the standard internal representation of an attribute. In the directory model used in this specification, the more familiar `ldapDisplayName` represents an attribute.

resource: In WS-Transfer, resources are entities that have an XML representation and can be addressed by an endpoint reference [WXFR].

SOAP action: The HTTP request header field used to indicate the intent of the SOAP request, using a URI value. See [SOAP1.1] section 6.1.1 for more information.

SOAP body: A container for the payload data being delivered by a SOAP message to its recipient. See [SOAP1.2-1/2007] section 5.3 for more information.

SOAP fault: A container for error and status information within a SOAP message. See [SOAP1.2-1/2007] section 5.4 for more information.

SOAP fault code: The algorithmic mechanism for identifying a SOAP fault. See [SOAP1.2-1/2007] section 5.6 for more information.

SOAP fault detail: A string containing a human-readable explanation of a SOAP fault, which is not intended for algorithmic processing. See [SOAP1.2-1/2007] section 5.4.5 for more information.

SOAP fault subcode: An element of a SOAP fault, defined in [SOAP1.2-1/2003].

SOAP header: A mechanism for implementing extensions to a SOAP message in a decentralized manner without prior agreement between the communicating parties. See [SOAP1.2-1/2007] section 5.2 for more information.

SOAP header block: The XML block containing the SOAP header entries within a SOAP header. See [SOAP1.2-1/2007] section 5.2.1 for more information.

SOAP message: An XML document consisting of a mandatory SOAP envelope, an optional SOAP header, and a mandatory SOAP body. See [SOAP1.2-1/2007] section 5 for more information.

SOAP mustUnderstand attribute: A global, Boolean attribute that is used to indicate whether a header entry is mandatory or optional for the recipient to process. See [SOAP1.2-1/2007] section 5.2.3 for more information.

Uniform Resource Identifier (URI): A string that identifies a resource. The URI is an addressing mechanism defined in Internet Engineering Task Force (IETF) Uniform Resource Identifier (URI): Generic Syntax [RFC3986].

Web Services Description Language (WSDL): An XML format for describing network services as a set of endpoints that operate on messages that contain either document-oriented or procedure-oriented information. The operations and messages are described abstractly and are bound to a concrete network protocol and message format in order to define an endpoint. Related concrete endpoints are combined into abstract endpoints, which describe a network service. WSDL is extensible, which allows the description of endpoints and their messages regardless of the message formats or network protocols that are used.

WSDL message: An abstract, typed definition of the data that is communicated during a WSDL operation [WSDL]. Also, an element that describes the data being exchanged between web service providers and clients.

WSDL operation: A single action or function of a web service. The execution of a WSDL operation typically requires the exchange of messages between the service requestor and the service provider.

WSDL port type: A named set of logically-related, abstract Web Services Description Language (WSDL) operations and messages.

XML: The Extensible Markup Language, as described in [XML1.0].

XML namespace: A collection of names that is used to identify elements, types, and attributes in XML documents identified in a URI reference [RFC3986]. A combination of XML namespace and local name allows XML documents to use elements, types, and attributes that have the same names but come from different sources. For more information, see [XMLNS-2ED].

XML Schema (XSD): A language that defines the elements, attributes, namespaces, and data types for XML documents as defined by [XMLSCHEMA1/2] and [W3C-XSDXMLSCHEMA2/2] standards. An XML schema uses XML syntax for its language.

MAY, SHOULD, MUST, SHOULD NOT, MUST NOT: These terms (in all caps) are used as defined in [RFC2119]. All statements of optional behavior use either MAY, SHOULD, or SHOULD NOT.

1.3 Overview

IMDA is an extension to the WS-Transfer protocol [WXFR]. WS-Transfer permits the XML [XML10] representation of resources to be created, modified, retrieved, and deleted. WS-Transfer operates at the level of granularity of the complete representation of an entire resource. That is, when the resource is retrieved, the complete contents of the resource must be retrieved. There is no mechanism in WS-Transfer to specify that only a portion of the resource should be retrieved or what that portion should be. Similarly, when the resource is to be created or modified, the client must supply a new XML representation for the entire resource. During the creation of a resource, there is no means by which the caller can specify only the portion of interest of the resource and allow the server to fill in the remainder of the representation with suitable defaults. Nor is there a mechanism during resource modification by which the caller can specify only the portion of the representation that should be changed and what the new contents for just that portion should be.

Such operations can be difficult for a client to use. For example, if a client wants to modify a single portion (for example, the portion specifying a person's given name) on a resource representing that person, the client would need to read the entire resource, change the value of that one portion of the representation, and then send the entire representation back to the server. The result is increased network traffic and bandwidth consumption. In a usage such as a directory service, where each resource might be a directory object that could contain dozens or hundreds of attributes, and each attribute could contain multiple values, a more efficient protocol is desirable. The IMDA extensions to WS-Transfer [WXFR] were designed for this purpose.

IMDA adds protocol extensions to WS-Transfer to permit it to work at the level of granularity of portions of the representation of a resource. It allows the client to specify just the portion of the resource to be created, modified, or retrieved. To do so, IMDA defines such fine-grained extensions to the following WS-Transfer Web Services Description Language (WSDL) operations:

- **Put**
- **Create**
- **Get**

Requests that make use of IMDA extensions can be identified by the presence of an IMDA-specific SOAP header.

Additionally, the specification of WS-Transfer provides only a small set of SOAP faults for a server to return. This set is insufficient for many error conditions that a server would need to report to the client, forcing the server to invent its own nonstandard SOAP fault codes. IMDA extends the WS-Transfer set of faults by specifying additional SOAP faults that a server is permitted to return to the client to indicate that an error occurred while processing the request. The intent is to improve interoperability between clients and servers by providing a standardized set of errors that both sides of the communication session can understand. IMDA specifies SOAP faults for the three WS-Transfer operations listed in this section as well as for the WS-Transfer Delete operation (which is not otherwise extended by IMDA).

1.3.1 Identity Objects

IMDA operates on a type of resource known as an identity object. An identity object is a collection of one or more identity attributes. An example of a kind of identity object is a directory object. Like any resource that can be accessed through WS-Transfer, identity objects can be represented as XML documents.

An identity attribute is a collection of one or more identity attribute values. An identity attribute is named by an identity attribute type, which is an expression that designates an identity attribute within an identity object. The format of the expression is determined by the expression's dialect, as described in section 1.3.2. For example, if the identity object corresponds to a directory object, an identity attribute could correspond to a directory attribute of that directory object, and the LDAP display name<1> of that directory attribute could serve as the identity attribute type of the corresponding identity attribute.

The identity attribute value is represented as an XML element. An identity attribute can contain one or more identity attribute values. For example, in an identity attribute for a user's telephone numbers, each phone number could be represented as an identity attribute value.

1.3.2 Dialect

A single identity attributes within an identity object can be identified in multiple ways. In other words, there could be multiple identity attribute types that each name the same identity attribute. For example, in the previous section, the use of an LDAP display name (for example, givenName) as a identity attribute type was given. Another means of naming the same identity attribute, in the example case of each identity object corresponding to a directory object, might be to use the object identifier (OID) of the directory attribute. The OID acts as a different identity attribute type that names the same identity attribute. These two distinct forms of identity attribute types are each a different dialect of identity attribute type.

Formally, a dialect is a specification of the format of identity attribute types. Each dialect is uniquely identified by a unique Uniform Resource Identifier (URI).

1.4 Relationship to Other Protocols

The IMDA protocol extensions depend on WS-Transfer [WXFR], built on top of SOAP [SOAP1.2-1/2003], as shown in the following diagram.

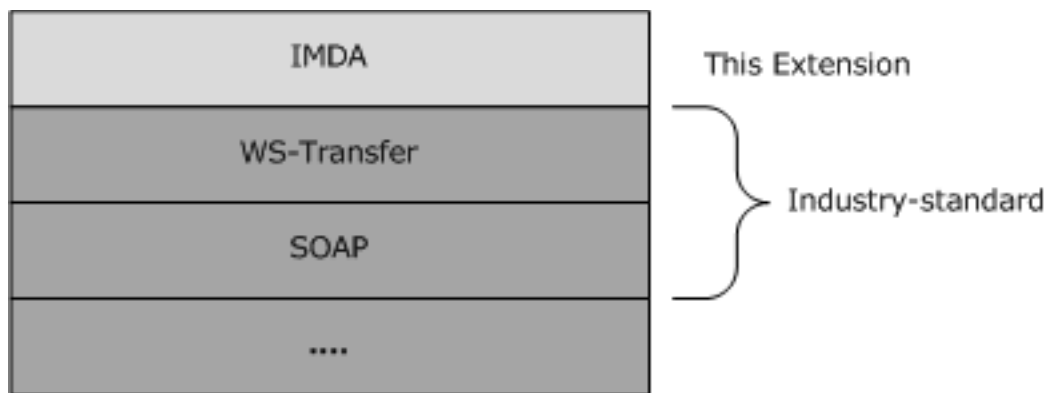


Figure 1: IMDA protocol stack

1.5 Prerequisites/Preconditions

This protocol extension does not assume any prerequisites or preconditions.

1.6 Applicability Statement

Use of the IMDA protocol extensions is suitable when access to XML representations of identity objects by means of a WS-Transfer is required and that access needs to be performed at a level of granularity less than the entire identity object's representation. IMDA cannot be used independently of WS-Transfer, so it might not be applicable in applications that have already standardized on a protocol

other than WS-Transfer for providing access to a directory service. It might also not be useful in applications where the directory objects are represented using a means other than XML.<2>

1.7 Versioning and Capability Negotiation

This document covers versioning issues in the following areas:

- **Supported Transports:** This protocol extension can be implemented using transports that support sending SOAP messages as described in section 2.1.
- **Protocol Versions:** This protocol extension is not versioned.
- **Capability Negotiation:** This protocol does not support capability negotiation.
- **Localization:** This protocol includes text strings in various SOAP faults. Localization considerations for such strings are specified in section 3.1.4.2.

1.8 Vendor-Extensible Fields

This protocol extension has no vendor-extensible fields.

1.9 Standards Assignments

There are no standards assignments for this protocol extension.

2 Messages

2.1 Transport

IMDA imposes no transport requirements or behaviors beyond those of the underlying WS-Transfer [WXFR] protocol. WS-Transfer provides SOAP bindings for both SOAP 1.1 [SOAP1.1] and SOAP 1.2 [SOAP1.2-1/2003]. All messages MUST be formatted as specified by either SOAP 1.1 or SOAP 1.2. <3>

2.2 Common Message Syntax

This section contains common definitions used by this protocol. The syntax of the definitions uses XML Schema as defined in [XMLSCHEMA1] and [XMLSCHEMA2], and Web Services Description Language as defined in [WSDL].

2.2.1 Namespaces

This specification defines and references various XML namespaces using the mechanisms specified in [XMLNS]. Although this specification associates a specific XML namespace prefix for each XML namespace that is used, the choice of any particular XML namespace prefix is implementation-specific and not significant for interoperability.

Two versions of the WS-Addressing namespace are included in the preceding table, corresponding to [WSAddressing] and [WSADDR]. Most of the IMDA protocol extensions make use of [WSADDR]. However, some of the faults incorporated into IMDA are based on the WS-Management [DMTF-DSP0226] protocol, which uses [WSAddressing].

2.2.2 Messages

This specification does not define any WSDL messages that are used in more than one operation.

2.2.3 Elements

The following table summarizes the set of common XML schema element definitions defined by this specification. XML schema element definitions that are specific to a particular operation are described with the operation.

2.2.4 Complex Types

2.3 Directory Service Schema Elements

This protocol extension does not access directory service schema classes or attributes. Implementations of this protocol extension MAY<9> map identity objects to directory objects and identity attributes/values to attributes and values stored on directory objects.

3 Protocol Details

The following sections describe the behavior of the IMDA protocol extension. As an extension to WS-Transfer [WXFR], the IMDA extensions follow the same client-server model, in which a client sends a SOAP message containing a request (either a Get, Put, Create, or Delete operation) to the server, and the server responds with a SOAP message containing the response (or a SOAP fault, if an error occurred during server processing).

In the following sections, the IMDA extensions are grouped by the two WS-Transfer WSDL port types to which they apply: the Resource port type (on which Get, Put, and Delete operations are processed) and the ResourceFactory port type (in which Create operations are processed). Prior to discussing the operation-specific behaviors associated with each port type, a common server processing section is included that contains protocol details common to all operations on all port types.

The client side of this protocol is simply a pass-through. That is, no additional timers or other state is required on the client side of this protocol. Calls made by the higher-layer protocol or application are passed directly to the transport, and the results returned by the transport are passed directly back to the higher-layer protocol or application.

3.1 Common Server Processing

This section describes processing common to all operations on all port types. Specifically, it documents the abstract data model and initialization procedure common to all port types. This section also discusses the SOAP header that is included by clients on SOAP messages to identify WS-Transfer requests that make use of the IMDA extensions. It describes the set of SOAP faults that IMDA provides for servers to use to communicate errors to clients.

3.1.1 Abstract Data Model

This section describes a conceptual model of possible data organization that an implementation maintains to participate in this protocol. The described organization is provided to facilitate the explanation of how the protocol behaves. This document does not mandate that implementations adhere to this model as long as their external behavior is consistent with that described in this document.

As noted earlier, IMDA operates on entities known as identity objects. Every IMDA operation, except for Create, targets exactly one existing identity object. The Create operation results in the creation of exactly one new identity object. An identity object is a collection of one or more identity attributes. Each identity attribute, in turn, is a collection of one or more identity attribute values. Identity attribute values are represented as XML elements.

For example, a user might be represented as an identity object. That identity object could have an identity attribute representing the user's given name, containing a single identity attribute value (for example, "John"). It could also have an identity attribute for the user's surname (for example, "Smith"). It might also have an identity attribute for the user's telephone numbers, which could contain multiple identity attribute values, one for each telephone number possessed by that user.

Like any resource that can be accessed through WS-Transfer, an identity object is represented as an XML document. The identity attributes contained in an identity object, the contents of those attributes, and the representation of the identity object (including its identity attributes and identity attribute values) as an XML document is implementation-defined. <10>

In IMDA, requests and responses refer to an identity attribute by specifying an identity attribute type. This is an expression that names an identity attribute. The expression is interpreted by the server according to the rules of the dialect in which that expression is written. The choice of dialect is implementation-specific. <11> IMDA requests that use identity attribute types contain an attribute that permits the client to name the dialect that it has used in the request. If the server understands

the named dialect, the server interprets the identity attribute type in accord with the rules of that dialect. Otherwise, the server rejects the request with a SOAP fault with a fault subcode of `wsm:FragmentDialectNotSupported`. Dialects are named by URIs, and the URI of a dialect is specified as the value of the attribute called **Dialect** in a request message.

The distinction between identity attributes and identity attribute types is an important one. An identity object contains one or more identity attributes. An identity attribute type, on the other hand, is a dialect-relative name for that identity attribute. As IMDA allows for multiple dialects, a single identity attribute can be referenced by multiple identity attribute types (that is, the identity attribute can have multiple names). This is analogous to LDAP [RFC2251], where an LDAP attribute in the LDAP data model can, at the protocol level, be referred to in multiple ways (for example, the LDAP display name of the attribute or the OID of the attribute).

3.1.2 Timers

These protocol extensions do not specify any timers.

3.1.3 Initialization

When this protocol initializes, it MUST begin listening on endpoints for the Resource and ResourceFactory port types. The URIs for the endpoints, as well as the transport and security mechanisms to use, are implementation-dependent.<12>

3.1.4 Message Processing Events and Sequencing Rules

This section describes the SOAP header processing and SOAP faults that are common to all operations.

3.1.4.1 (Updated Section) SOAP Header Processing

A client MUST include the IdentityManagementOperation element (see section 2.2.3.6) as a SOAP header in any WS-Transfer Get, Put, or Create request that uses the IMDA protocol extensions. The client SHOULD set the SOAP `mustUnderstand` attribute to true on this element.

When the server receives a WS-Transfer request on which the IdentityManagementOperation element is present as a SOAP header, one of two things MUST happen: either the server MUST process the request in accord with the IMDA extensions as described in this document, or the server MUST reject the request entirely. If the server receives a WS-Transfer request that does not contain the IdentityManagementOperation element as a SOAP header, the server SHOULD<13> treat the request as an ordinary WS-Transfer request that does not make use of the IMDA extensions.

3.1.4.2 SOAP Faults

This section documents the SOAP faults specified for use by servers that implement the IMDA protocol extensions. These faults SHOULD be used by servers while processing a WS-Transfer message that uses IMDA extensions to indicate to the client that a server-side error has occurred. Most of the following faults are adopted from the WS-Management [DMTF-DSP0226] protocol, and some are from WS-Transfer [WXFR] or WS-Addressing [WSAddressing]; IMDA assigns these faults a specific meaning within the context of a WS-Transfer operation that uses the IMDA extensions.

These faults in this section represent a common set shared by all operations.

Server implementations are permitted to return additional faults beyond those described as follows. However, to maximize interoperability, implementations SHOULD make use of the following faults where applicable.

Some of the SOAP faults documented as follows specify English-language text in their fault reason. Server implementations are permitted to localize this text to other languages. Such localizations

SHOULD maintain, to the extent possible, the same meaning as the English text supplied in this document.

All SOAP faults defined in this document MUST be sent as described in section 6 of [WSASB]. In the tables in the following sections, the following apply:

- [Code] is the SOAP fault code.
- [Subcode] is the SOAP fault subcode.
- [Action] is the SOAP action URI for the fault.
- [Reason] is a human-readable explanation of the error.
- [Details] is an illustrative example of the fault detail. If not present, IMDA does not specify a fault detail for the fault.

The following table summarizes the faults (grouped by fault subcode) specified in this section.

Fault subcode	Description
wsman:AccessDenied	The server rejected the operation due to access control policies.
wsman:AlreadyExists	The identity object requested to be created already exists.
wsman:CannotProcessFilter	The identity attribute type was invalid for the dialect or specified an identity attribute that was invalid for the identity object.
wsa2004:DestinationUnreachable	The identity object specified as the target of the operation does not exist.
wsman:EncodingLimit	The client's request included too many elements.
wsa2004:EndpointUnavailable	Insufficient server-side resources to process the request.
wsman:FragmentDialectNotSupported	The operation specified a dialect not supported by the server.
wxf:InvalidRepresentation	Performing the operation would result in an invalid representation of an identity object.
wsman:SchemaValidationError	The client's request did not conform to the XML Schema or was syntactically invalid XML.
UnwillingToPerform	The server cannot perform the requested operation.

3.1.4.2.1 (Updated Section) wsman:AccessDenied

If the client sends a request that the server is unable or unwilling to perform because of an access control restriction, the server SHOULD reject the operation and return a SOAP fault with a fault subcode of wsman:AccessDenied (as defined in Table 2 of [DMTF-DSP0226]).

Implementations MAY<14> supply a fault detail of their choosing.

the server SHOULD reject the operation and return a SOAP fault with the fault subcode wsman:CannotProcessFilter (as defined in Table 6 of [DMTF-DSP0226]). The fault detail MAY contain an **AttributeTypeNotValidForDialect** element and/or an **AttributeTypeNotValidForEntry** element, as described in sections AttributeTypeNotValidForDialect (section 2.2.3.3) and AttributeTypeNotValidForEntry (section 2.2.3.4).

If the client sends a Get, Put, or Delete request in which the target of the operation is an identity object that does not exist, the server SHOULD reject the operation and return a SOAP fault in which the fault subcode is wsa2004:DestinationUnreachable (as defined in Table 10 of [DMTF-DSP0226]).

Implementations MAY<18> supply a fault detail or fault reason that differs from the one specified in [DMTF-DSP0226].<19>

If the server determines that the client has included too many elements in a request (for example, too many AttributeType elements in a Get request or too many Change elements in a Put request), the server SHOULD reject the operation and return a SOAP fault with a fault subcode of wsman:EncodingLimit (as defined in Table 11 of [DMTF-DSP0226]). The fault detail SHOULD contain a wsman:FaultDetail element containing the following value:

This section describes the server behavior of the IMDA protocol extensions as they apply to WS-Transfer's [WXFR] Resource port type. In WS-Transfer, this port type is used to process three WSDL operations:

- Get
- Put
- Delete

IMDA defines new SOAP messages for the first two operations, which can be used to request that the Get and Put operations be performed at the level of granularity of identity attributes and their values, rather than at the level of the entire identity object (as provided for by unextended WS-Transfer). The Delete operation, on the other hand, always operates at the level of granularity of an identity object level. It is included in this section because IMDA specifies additional SOAP faults (beyond those defined in WS-Transfer) that can be used by a server to respond to a Delete operation.

Each of these operations is performed against a single identity object specified in the request. This identity object is called the target of the operation. The target of the operation SHOULD be specified by one or more SOAP headers. The choice of these SOAP headers and how they specify the target of the operation is not defined by the IMDA protocol extensions but rather by the service that employs the IMDA extensions.<30>

3.2.1 Abstract Data Model

3.2.2 Timers

There are no timers in this protocol extension.

3.2.3 Initialization

See the initialization in the common processing section 3.1.3.

3.2.4 Message Processing Events and Sequencing Rules

The Resource port type includes three operations.

The server's processing of this operation depends on the contents of the BaseObjectSearchRequest in the SOAP request message (see section BaseObjectSearchRequest (section 3.2.4.1.2.1)). There are two cases:

1. If the BaseObjectSearchRequest contains one or more AttributeType elements, the server SHOULD retrieve the values of the identity attributes which that are specified by the identity attribute types contained in the BaseObjectSearchRequest element. The server then assembles and returns a SOAP message containing a BaseObjectSearchResponse as the SOAP body. The contents of the BaseObjectSearchResponse are the identity attribute values for the identity attributes requested by the client, from the identity object specified by the client as the target of the Get operation. For each identity attribute, the identity attribute value(s) for that attribute are contained in a **PartialAttribute** element. There MUST be exactly one **PartialAttribute** element in the **BaseObjectSearchResponse** element for each **AttributeType** element in the BaseObjectSearchRequest element, and the order of the PartialAttribute elements in the response MUST be the same as the order of the AttributeTypes in the request.

If an identity attribute specified in the client's request does not exist on the targeted identity object, or if the server refuses to return the values of an identity attribute to the client due to access control policy, the server MUST include an empty PartialAttribute element in the BaseObjectSearchResponse in the position that would otherwise have been occupied by that identity attribute's values.

2. If the BaseObjectSearchRequest contains no AttributeType elements, the server SHOULD assemble an implementation-defined XML representation of the entire identity object

including all the identity attributes of the object, except it SHOULD exclude from that representation any identity attributes that the client is not permitted to retrieve the values of due to access control policy. The server MAY exclude additional identity attributes as well.

The server then assembles and returns a SOAP message containing a BaseObjectSearchResponse as the SOAP body. The contents of the BaseObjectSearchResponse are a single PartialAttribute element. The contents of that PartialAttribute element is the XML representation of the identity object.

This mode of operation is similar to performing a WS-Transfer Get operation without using the IMDA protocol extensions.

If an error occurs while processing this operation, the server SHOULD reject the operation and return one of the SOAP faults specified in section 3.1.4.2.

IMDA defines a new request message for this operation that permits the client to specify only a portion of the identity object that is to be created, with the server supplying any remaining portions of the identity object when it creates the object.

Note that unlike operations performed on the Resource port type, the Create operation does not target a specific identity object but rather causes the creation of an identity object that can subsequently be targeted by operations on the Resource port type.

Upon receiving the request, the server creates a new identity object. For each identity attribute named in an AttributeTypeAndValue element in the AddRequest message, that identity attribute in the newly created object is assigned the identity attribute values specified in that AttributeTypeAndValue element. If the identity object cannot be created or the identity attributes cannot be set as specified by the client (for example, due to reasons of access control policy or constraints that prohibit setting the specified identity attribute), the server MUST fail the Create request and MUST not create the identity object.

The creation of the identity object and the assignment of identity attribute values SHOULD be performed as a single atomic transaction. If any of the specified identity attributes cannot be set to the specified values, the entire operation SHOULD be rejected, and the server SHOULD not create the identity object.

Servers MAY<37> set other identity attributes on the identity objects to implementation-defined defaults as part of the object creation.

If an error occurs while processing this operation, the server SHOULD reject the operation and return one of the SOAP faults specified in section 3.1.4.2.

3.3.4.1.1 Messages

The following WSDL message definitions are specific to this operation.

3.3.4.1.1.1 AddRequestMessage

The AddRequestMessage is sent by the client to the server to request the creation of a new identity object and to specify values for identity attributes on the identity object to be created.

3.3.4.1.2 Elements

The following XML schema element definitions are specific to this operation.

3.3.4.1.2.1 AddRequest

This element is used by the client to specify identity attribute values to be added to identity attributes on the identity object that is to be created. Zero or more identity attributes can be specified, and for each specified identity attribute, one or more identity attribute values can be supplied. When the object is created, those identity attributes specified in the AddRequest have their values initially set to the values specified by the client.

While there can be multiple occurrences of the AttributeTypeAndValue element, there is only one occurrence of the Dialect attribute on the AddRequest element. Therefore, all AttributeType elements use the same dialect.

AttributeTypeAndValue: Specifies an identity attribute to be set on the to-be-created identity object and the identity attribute value(s) that are to be added to that identity attribute. This element can be present multiple times, permitting values for multiple identity attributes to be specified.

It is permitted for multiple AttributeTypeAndValue elements to specify the same identity attribute. In that case, the values added to the specified identity attribute are the union of all the values specified in the AttributeTypeAndValue elements that specify that attribute. If the server does not permit more than one value to be added to the specified identity attribute, the server SHOULD reject the operation with a wxf:InvalidRepresentation SOAP fault.<38>

AttributeTypeAndValue.AttributeType: The content of this element is an identity attribute type expressed in the dialect specified by the Dialect attribute. This specifies the identity attribute to which the values are to be added.

AttributeTypeAndValue.AttributeValue: Contains the identity attribute value(s) to be added to the specified identity attribute when the object is created.

Dialect: The value of this attribute is the URI of the dialect used for the identity attribute types.

3.3.5 Timer Events

There are no timer events in this protocol extension.

3.3.6 Other Local Events

There are no other local events in this protocol extension.

4 (Updated Section) Protocol Examples

In this section, several sample IMDA operations are presented. First, an identity object is created using a Create operation. Information from that identity object is then retrieved using Get operations. Finally, the object is modified using a Put operation.

For illustrative purposes, the chosen XML representation of identity objects in this section is the XML view of directory objects shown in [MS-ADDM] section 2.3 of [MS-ADDM]. For the Get and Put examples, the SOAP header defined in [MS-ADDM] section 2.5 of [MS-ADDM] are used to specify the object that is the target of the operation.

4.1 (Updated Section) Example of Creating an Identity Object

In this section, a new identity object is created using a Create operation with the IMDA protocol extensions. During the creation, identity attribute values are specified for five identity attributes. For one of the identity attributes (named by the identity attribute type "addata:otherTelephone"), two identity attribute values are specified. The dialect used for the identity attribute types is the XPath 1.0-derived dialect from [MS-ADDM] section 2.4 of [MS-ADDM]. In the response, a wxf:ResourceCreated element is returned, the contents of which are used to target the IMDA operations against this newly created identity object in the subsequent examples.

4.2 (Updated Section) Example of Retrieving Attribute Types from an Identity Object

In this example, three identity attributes are retrieved from the identity object created in the preceding example using a Get operation with the IMDA protocol extensions. One of the identity

attributes has multiple identity attribute values, and one of the requested identity attributes does not exist on the identity object and so is returned as an empty PartialAttribute element. As in the preceding example, the dialect used for the identity attribute types is the XPath 1.0-derived dialect from [MS-ADDM] section 2.4 of [MS-ADDM].

4.3 Example of Retrieving the Complete XML Representation of an Identity Object

In the previous example, the SOAP request specified the identity attribute types to be returned by the server. In the example in this section, the request does not specify any identity attribute types, so the server returns the XML representation of the entire identity object as the contents of a single `PartialAttribute` element.

As seen in the response that follows, a number of identity attributes are present that were not specified in the Create request. The values of these attributes were defaulted by the server implementation when the identity object was created.

5 Security

5.1 Security Considerations for Implementers

There are no known additional security considerations for these protocol extensions, but implementers have to consider the security implications of the data that they expose by means of these extensions. When exposing access to identity objects that can contain sensitive information, server implementers are encouraged to use transport mechanisms that support encryption and integrity-verification of the messages. Server implementers are also encouraged to enforce access controls prior to performing any operation against an identity object.

This protocol extension has no security parameters.

For ease of implementation, the full WSDL is provided below. After the full WSDL, a binding is included for using the Resource and ResourceFactory port types with SOAP 1.2 [SOAP1.2-1/2003] over the "net.tcp" transport [MC-NMF]. This binding is included to illustrate how the IdentityManagementOperation SOAP header is used in the SOAP messages and should not be construed to restrict servers from implementing the IMDA protocol extensions using other versions of SOAP or over other transports.

<30> Section 3.2: Microsoft implementations of WS-Transfer: Identity Management Operations for Directory Access Extensions specify the target via the "instance" and "objectReferenceProperty" SOAP headers defined in [MS-ADDM] section 2.5 of [MS-ADDM].

<31> Section 3.2.4.1: Microsoft implementations of WS-Transfer: Identity Management Operations for Directory Access Extensions use the XML view defined in [MS-ADDM] section 2.3.2 of [MS-ADDM], namely, an identity object is represented as an XML element in the <http://schemas.microsoft.com/2008/1/ActiveDirectory/Data> XML namespace named for the most-specific structural class ([MS-ADTS] section 3.1.1.1.4) of the directory object to which the identity object corresponds.

<32> Section 3.2.4.1: Microsoft implementations of WS-Transfer: Identity Management Operations for Directory Access Extensions exclude those identity attributes that correspond to constructed attributes in the corresponding directory object.

<33> Section 3.2.4.1.3.1: Microsoft implementations of WS-Transfer: Identity Management Operations for Directory Access Extensions format identity objects and the identity attribute values using the rules specified in [MS-ADDM] section 2.3 of [MS-ADDM], namely:

An identity object is represented as an XML element in the <http://schemas.microsoft.com/2008/1/ActiveDirectory/Data> XML namespace named for the most-specific structural class ([MS-ADTS] section 3.1.1.1.4) of the directory object to which the identity object corresponds.

Identity attribute values are formatted as follows:

- Each identity attribute value is contained in a separate "value" element in the <http://schemas.microsoft.com/2008/1/ActiveDirectory> XML namespace.
- The "value" elements are contained inside a single element named for the LDAP display name of the directory attribute (or, for synthetic attributes, the name of the synthetic attribute).

One instance of the PartialAttributeXmlType (that is, a PartialAttribute element) can contain a single instance of the element named for the attribute, but that element can in turn contain multiple "value" elements, allowing multiple identity attribute values to be specified.

<34> Section 3.2.4.2: Microsoft implementations of WS-Transfer: Identity Management Operations for Directory Access Extensions perform modifications to the ad:container-hierarchy-parent and ad:relativeDistinguishedName synthetic attributes (see [MS-ADDM] sections 2.3.3.2 and 2.3.3.4 of [MS-ADDM]) as an atomic transaction separate from the modification of any other identity attributes that are present in the Put request. A single Put request could consist of up to two atomic transactions: one for the ad:container-hierarchy-parent and/or ad:relativeDistinguishedName modifications and one for any remaining modifications in the Put request. The transactions are performed in that order, and a failure in the latter transaction will not undo the changes made by the preceding transaction.

If there is more than one modification to the ad:container-hierarchy-parent synthetic attribute, or more than one modification to the ad:relativeDistinguishedName synthetic attribute, in a single Put request, the server will reject the request with a UnwillingToPerform SOAP fault.

<35> Section 3.2.4.2: Microsoft implementations of WS-Transfer: Identity Management Operations for Directory Access Extensions return **da:UnwillingToPerformFault** specified in section 3.1.4.2.10 without performing any modifications to the identity object if there are no change elements present in the **ModifyRequest**.

<36> Section 3.2.4.2.3.1: Microsoft implementations of WS-Transfer: Identity Management Operations for Directory Access Extensions permit an AttributeValue element to be specified in the Change element for a "delete" modification. In addition, the identity attribute value(s) to be deleted can also be specified by using an XPath 1.0-derived selection language expression containing a selection predicate (~~see [MS-ADDM] section 2.4 of [MS-ADDM]~~) as the contents of the AttributeType element in the Change element.

If both a predicate selection element and one or more AttributeValue elements are supplied, the union of the two is processed. (In other words, both the values specified by the predicate and by the AttributeValues are deleted.)

If neither a selection predicate nor an AttributeValue elements is supplied, then all the values of the identity attribute are deleted.

<37> Section 3.3.4.1: In Microsoft implementations of WS-Transfer: Identity Management Operations for Directory Access Extensions, the identity objects correspond to directory objects in Active Directory, and the identity attributes correspond to directory attributes and synthetic attributes on the directory object [MS-ADDM]. Therefore, when an object is created, its attributes are defaulted in accordance with the Active Directory processing rules for object creation (see [MS-ADTS], in particular, section 3.1.1.5.2).

<38> Section 3.3.4.1.2.1: If the server does not permit more than one value to be added to the specified identity attribute, Microsoft implementations of WS-Transfer: Identity Management Operations for Directory Access Extensions generate a da:UnwillingToPerform SOAP fault.

8 Change Tracking
